Each year, Cooper University Health Care celebrates our nursing community and collaborative teams with the Nursing Excellence Awards. This packet provides the nomination form and information about the various awards.

Please note the following:

The Outstanding Team Award will be presented to a team that demonstrates excellence in patient care services and collaboration with all members of the health care team. This award is open to ALL Cooper Camden employees.

- Professional nurses and advanced practice nurses, in the ambulatory care or inpatient setting at any Cooper University Health Care location, are eligible to be nominated for Nursing Excellence Awards.
- Allied health professionals (non-nurses) are eligible to be nominated for the Allied Health Professional Excellence Award.
- Allied health professionals (non-nurses) from the Patient Care Services hospital pool team are eligible to be nominated for The Miss Donna Glover Memorial Award.
- Physicians are eligible to be nominated for the Nursing-Physician Partnership Award.
- Any non-nurse member of the patient care team is eligible to be nominated for the Barbara and Jack Tarditi Award for Excellence in Service.
- The Carol G. Tracey Compassion Award is open to ALL Cooper Camden employees.
- All nominees must be Cooper employees in good standing.
- Awards are to be used for education, training, or research.

- ✓ Shows a high level of commitment to Cooper University Health Care.
- ✓ *Assists in shaping the delivery of health care within organization and practice area.*
- ✓ Demonstrates innovation in the field of advanced clinical practice roles.
- ✓ Exhibits excellence in patient care by impacting measurable outcomes.
- ✓ Recognized by colleagues as a valued, collaborative member of the health care team while demonstrating autonomy in daily practice.
- ✓ Actively mentors and educates peers.
- ✓ Consistently serves as a patient care advocate.

• **The Philip and Carole Norcross Award for Nurse Leadership**

Eligibility: Professional nurses and advanced practice nurses in leadership roles who have been employed by Cooper University Health Care for a minimum of 12 months.

Description/Criteria: This award is presented to a nurse leader who demonstrates the ability to create an environment in which clinical excellence is fostered and independent problem solving and solution seeking are valued. This is evidenced by the following:

Description/Criteria: This award is presented to a nurse who serves as an exceptional mentor to colleagues and other members of the health care team.

This is evidenced by the following:

- ✓ Fosters the integration of inexperienced and new staff into the team.
- ✓ Demonstrates excellent coaching and guidance skills.
- ✓ Motivates team members to achieve higher standards and level of practice.
- ✓ Fosters an environment of learning.
- ✓ Identifies potential problems and takes the initiative to intervene.
- ✓ Supports new team members in problem-solving issues.
- ✓ Demonstrates excellent interpersonal and communication skills.
- ✓ Identifies learning/developmental needs of staff and acts as a resource in supporting new staff.
- ✓ Serves as an advisor to members of the health care team.

Awards: Eligibility, Description, and Criteria

- **The Barbara and Jack Tarditi Award for Excellence in Nursing Research**

Eligibility: Professional nurses and advanced practice nurses or nursing teams who have been employed by Cooper University Health Care for a minimum of 12 months.

Description/Criteria: This award is presented to a nurse or nursing team in recognition of their contribution to the advancement of nursing by either participating in nursing research, a quality improvement project or evidence-based practice. This is evidenced by the following:

- ✓ Active and ongoing engagement in either a nursing IRB-approved research study, quality improvement project, or evidence-based practice that has resulted in change to nursing practice with the potential for wider change within nursing education, nursing practice, or nursing research.
- ✓ Research, quality improvement, or evidence-based practice project disseminated to a broader nursing audience (i.e. podium, poster presentation, manuscript submission or publication, Cooper or non-Cooper committee, etc.).

- **The Shaina Horton Memorial Award for Excellence in Service**

Eligibility: Professional nurses and advanced practice nurses who have been employed by Cooper University Health Care for a minimum of 12 months.

Description/Criteria: This award is presented to a professional nurse who demonstrates excellence in patient-centered care. This is evidenced by the following:

- ✓ Exhibits consideration of the patient's cultural traditions, personal preferences, and values during patient interactions and care delivery.
- ✓ Exhibits consideration of the patient's family situations, social circumstances, and lifestyles during patient interactions and care delivery.
- ✓ Focuses on the patient's physical, emotional, and social needs when delivering care.
- ✓ Demonstrates a positive attitude in all patient and family interactions.
- ✓ Serves as a role model to members of the health care team.
- ✓ Acknowledged as a patient advocate by members of the health care team.
- ✓ Establishes positive relationships with patients and families.
- ✓ Demonstrates excellent communication and interpersonal skills.
- ✓ Promotes a patient-centered care environment.
- ✓ Recognized for their contribution to patient and family satisfaction.

Awards: Eligibility, Description, and Criteria

- **The Lori Osinski Rising Star Award**

Eligibility: Professional nurses new to practice within the last two years.

Description/Criteria: This award is presented to a nurse who has completed nursing orientation, has less than two years of nursing experience, and demonstrates excellence in the fundamentals of nursing practice and patient care. This is evidenced by the following:

- ✓ Actively involved in unit – specific and/or hospital-based committees.
- ✓ Member of professional organization.
- ✓ Recognized for their contributions to the nursing profession (i.e.: nominated for Daisy award, unit-based project, ladder applicant).
- ✓ Recognized for their desire and action to make their unit/patient care unit better
- ✓ Acknowledged by peers as an excellent patient care provider.
- ✓ Demonstrates a keen desire for professional growth with an eagerness to learn and increase knowledge base by reaching out to peers with questions or concerns.
- ✓ Recognized by peers/supervisors as a natural leader.
- ✓ Inspires others to follow by example.

- **The Lori Osinski Award for Excellence in Procedural Nursing**

Eligibility: Professional nurses or advanced practice nurses working in a procedural area employed by Cooper University Health Care for a minimum of two years.

Description/Criteria: This award is presented to a nurse who demonstrates excellence in their clinical specialty. Excellence in patient care delivery is evidenced by the following:

- ✓ Demonstrates innovative ways to advance the practice of procedural nursing.
- ✓ Commitment to patient quality care as evidenced by contributing to favorable clinical outcomes.
- ✓ Acknowledged by peers as an excellent care provider.
- ✓ Recognized for their contribution to patient and family satisfaction.
- ✓ Demonstrates excellence in teamwork and collaboration with members of the health care team.
- ✓ Patient-centered approach to decision-making, problem solving, and care delivery.
- ✓ Foster an environment of learning.
- ✓ Promotes a family-centered care environment.

- ✓ Demonstrates excellence in teamwork and collaboration with members of the health care team.
- ✓ Contributes to increasing the level of health and well-being for patients, families, and the community.
- ✓ Promotes a patient and family-centered care environment.
- ✓ Establishes positive relationships with patients and families.
- ✓ Acknowledged as a patient advocate.
- ✓ Demonstrates excellent communication and interpersonal skills.
- ✓ Contributes to systems and processes that support excellence in patient care.

• The Women's Board of Cooper University Health Care Allied Health Professional Excellence Award (Non-Nursing)

Eligibility: Allied health professionals (non-nurses) who have been employed by Cooper University Health Care for a minimum of 12 months. Allied health professionals include social workers; mental health professionals; physical; occupational; speech and language and respiratory therapists; radiology; surgical; diagnostic and other technicians; dieticians and clinical pharmacists.

Description/Criteria: This award is presented to an allied health professional member of the health care team who demonstrates a collaborative, productive working relationship with their nursing colleagues. This is evidenced by the following:

- ✓ Acknowledged by peers as a valued team member.
- ✓ Demonstrates excellence in teamwork and collaboration with members of the health care team.
- ✓ Able to resolve areas of potential conflict with either team members, patients or their families.
- ✓ Exhibits a willingness to help even if the help required falls outside the employees specific job requirements.
- ✓ Demonstrates professionalism, excellent communication and interpersonal skills.

• The Miss Donna Glover Memorial Award

Eligibility: A non-nurse member of the Patient Care Services hospital pool team interested in developing professionally. This team member has been employed by Cooper University Health Care for a minimum of 12 months. Non-nurse team members include critical care technicians, nurse associates, constant attendance sitters, and telesitters.

Description/Criteria: This award is presented to a non-nurse member of the ancillary health care team who demonstrates excellence in patient care services. This is evidenced by:

- ✓ Acknowledged by peers as a valued team member.
- ✓ Recognized for contribution to patient and family satisfaction.
- ✓ Demonstrates excellence in teamwork and collaboration with members of the health care team.
- ✓ Exhibits a willingness to help, even if the help required falls outside of the team member's specific job requirements.
- ✓ Promotes a patient and family-centered care environment.
- ✓ Establishes positive relationships with patients and families.
- ✓ Acknowledged as a patient advocate.
- ✓ Demonstrates excellent communication and interpersonal skills.
- ✓ Contributes to systems and processes that support excellence in patient care.

• Nursing Alumni Excellence Award for Nursing-Physician Partnership

Eligibility: Physicians who have been employed by Cooper University Health Care for a minimum of 12 months.

Description/Criteria: This award is presented to a physician who demonstrates a collaborative, productive working relationship with nursing colleagues.

This is evidenced by the following:

- ✓ Acknowledged by peers as a valued team member.
- ✓ Demonstrates excellence in teamwork and collaboration with members of the health care team.
- ✓ Demonstrates a patient-centered approach to decision making, problem solving, and care delivery.
- ✓ Able to resolve areas of potential conflict with either team members, patients, or their families.
- ✓ Serves as a mentor to members of the health care team.
